Subscribing to the Central East LHIN website through the MY PAGE button is the easiest way to stay updated on the latest news and initiatives at the Central East LHIN. Since its introduction in 2007 over 1,500 people have created their own unique MY PAGE account and are now receiving email notification when new content is added to the Central East LHIN public website.

Subscription topics are constantly changing so be sure to update your account every three or four months. Some of the more popular subscription topics include:

- Board of Directors – for access to information presented at monthly open board meetings
- Get Connected with Care – for updates on funded projects and programs
- Newsroom – for the latest news releases and newsletters
- Resource Documents – for access to files, forms, frameworks, funding updates etc.
